

NOTICE OF PUBLIC HEARING

SHELBYVILLE BOARD OF ZONING APPEALS

Notice is hereby given that the Shelbyville Board of Zoning Appeals will hold a Public Hearing on **Tuesday, October 14, 2025 at 7:00 PM** in the Common Council Chambers at Shelbyville City Hall, 44 W Washington Street, to consider four petition(s):

- **BZA 2025-16** A petition by Aaron Callis for four Development Standards Variances, at the property located at 2205 N. Michigan Rd. Shelbyville, IN 46176 to build a barn for indoor storage of boats, campers, and trailers

The requested variances are from the following sections of the Unified Development Ordinance:

- **Four Development Standards Variances,**
 - A-UDO 5.23-A-2: *Height Standards-Maximum Accessory Structure Height*
 - B-UDO 5.24-A: *Home Occupation Standards - Business Activities*
 - C-UDO 5.24-D: *Home Occupation Standards - Owner/ Operator*
 - D-UDO 5.24-G: *Home Occupation Standards - Business Area*
- **BZA 2025-17:** A petition by Kris & Tangody Fewell for a Development Standards Variance UDO 5.55-E; Setback Standards at the property located at 1026 Summerway Dr. Shelbyville, IN 46176. This will allow the construction of a detached garage, with a side yard set back reduced to 2 feet off the east property line.
- **BZA 2025-18:** A petition by Sunshine House for a Special Exception Use at the property located at 21 W. Taylor St. Shelbyville, IN 46176. This will allow an overnight shelter at the property .

The application may be examined at the office of the Plan Commission of the City of Shelbyville, Indiana in City Hall located at 44 West Washington Street, Shelbyville, Indiana, 46176, Monday through Friday between the hours of 8:00 AM and 4:00 PM. City Staff will post documents to the website as they are completed and/or received.

Written comments in support of or in opposition to the petitions may be emailed to arude@cityofshelbyvillein.com or mailed to the Plan Commission Office (44 W. Washington Street, Shelbyville, IN, 46176) or filed with the Plan Commission Secretary at the Public Hearing and will be entered into public record and considered by the Board of Zoning Appeals at the hearing.

Public Hearings are open to the public and public comment will be heard at the meeting. The meeting will also be streamed via the City's Facebook page and via Zoom; a link to the City's Facebook page is available on the homepage of the City of Shelbyville's website and

the Zoom link has been included below. Public Comment will be taken in person and virtually via zoom. Any member of the public that wishes to provide public comment on a petition must contact the Plan Commission Secretary no later than 24 hours prior to the meeting pursuant to Board of Zoning Appeals Res. 2021-01. - f. If the member of the public is also the Petitioner in front of the Board of Zoning Appeals, identify one person who will appear in person.
